2. Previous minutes.

3. Matters Arising from previous minutes.

• GDC Sub-committee.

This sub-committee has now sat. *ZA* has been elected as chair. *CD* as vice-chair. *JB*, *EB*, *MD*, *CMcL*, *HA*, *DMcS* to serve as ordinary members. 5. Covid Top-ups

A discussion took place which concentrated on the unfairness of how these have been applied. Further discussion about what it means to be a "committed" practice. This seems very hit or miss, and is determined by the percentage of private income by a practitioner, which is arguably of no concern of the Health Board or DPD.

6. Ventilation

7. AOCB

- MJ informed the meeting that Highland Health Board are reviewing the situation following the recent letters to LDC members ending the free uplifts.
- *EB* has asked John Lyon to arrange a meeting with the CDO Tim Ferris about Highland issues (eg. recruitment and retention). CDO will attend the next ADC meeting on the 4th August.
 CMcL asked that the opportunity is taken to raise the issue that the promised new model of care has not yet been forthcoming. *JB* expressed an interest in attending, but the ADC would have to approved this.
 NW suggested a "good cop / bad cop" approach where the CDO is made aware that the LDC are millitant and disatisfied with the CDO, whereas the ADC are representing the health board.
- CMcL updated us on his own practice's approach. He is offering NHS availability based upon SDCP priority groups.
